Fiscal Year 2015 Budget

As you may or may not have heard, Congress has passed the FY 2015 spending bill. While it is good that we have a working spending bill, and don't suffer from the threat of a shutdown like in the past, we are extremely disappointed in seeing further cuts to the IRS Budget down to \$10.9 billion—a reduction of 3 percent.

As Congress considered the FY 2015 spending package, NTEU was in ongoing discussions with the IRS. Now that the bill is approved and the numbers are final, we are working with the IRS to mitigate the impact on our employees and analyze how your work can be performed under these circumstances. We will work to ensure that you are not expected to bear the brunt of these cuts through increases in your overly heavy workloads.

We are working diligently to represent your interests and ensure the voices of our employees are heard!

2015 Mileage Reimbursement Rate



Proper reimbursement for federal employees using their privately-owned vehicles for government purposes is a high priority for NTEU. Currently, travelers are reimbursed 56 cents a mile. Mileage reimbursement is set by the General Services Administration (GSA) based on an annual review of costs, up to a ceiling set by the IRS for tax purposes.

Earlier this week, the IRS announced that they were increasing the gas mileage reimbursement rate from 56 cents a mile to 57.5 cents, effective January 1, 2015. Proper reimbursement for federal employees using their privately-owned vehicles for government purposes is a high priority for NTEU.

Commissioner Holds Media Briefing

Commissioner John Koskinen held a media briefing on December 19, 2014 about taxpayer services and how taxpayers can get help this filing season. When asked about how the IRS would deal with the severe budget cuts, the commissioner mentioned that a shutdown of the agency would be considered a "last resort." He also mentioned shorter seasons for seasonals, a hiring freeze, freezing overtime and more.



This short-sighted decision by some in Congress to once more deprive the IRS of the necessary resources to do its job will hurt all taxpayers. NTEU will continue to work diligently representing our members' interests and to ensure that the voices of employees are heard.
